PRIVACY POLICY

Effective from November 16, 2025

This Privacy Policy describes our Company's (**OYAONEMORE**) policies and procedures on the collection, use and disclosure of your information when you use this Application and tells you about your privacy rights and the law that protects you.

We use your personal data to provide and improve application. By using this Application, you agree to the collection and use of information in accordance with this Privacy Policy.

DATA WE COLLECT

Personal Data

While using this Application, we may ask you to provide us with certain personal information that can be used to contact or identify you. Personally identifiable this may include, but is not limited to:

Usage Data

Usage Data is collected automatically when using the Application and may include information such as your Device's Internet Protocol (IP) address, browser type, browser version, the pages of our Application that you visit, the time, date and duration of your visit, unique device identifiers and other diagnostic data.

When you access the Application by or through a mobile device, we may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile device's unique ID, the Internet Protocol (IP) address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

We may also collect information that your browser sends whenever you visit the Application or when you access Application by or through a mobile device.

Information Collected while Using the Application

RETENTION OF YOUR PERSONAL DATA

We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of application, or we are legally obligated to retain this data for longer periods.
